## PROCEDURE FOR APPROVAL OF COMPLETE APPLICATION OF LICENCE TO MANUFACTURER, REPAIRER AND DEALER IN WEIGHTS AND MEASURES

Every Individual, Firm, Society, Company or Corporation who or which intended to manufacture, deal or repair in weights and measures shall make online application to the Office of the Inspector of Legal Metrology within their respective District/Civil Sub-Division accompanied with all relevant papers.

After receiving the application the Inspector will scrutiny all the documents and inspect the premises of the applicant and prepare an inspection report and the same shall be submitted to the Office of the Assistant Controller of Legal Metrology within 15(fifteen) working days from the date of receipt of the application.

The Assistant Controller of Legal Metrology on receipt the application alongwith all relevant documents and the Inspection Report of the Inspector he shall examine all the papers and forwarded to the Controller of Legal Metrology within 5(five) working days with necessary recommendation.

The Controller of Legal Metrology or such Legal Metrology Officer authorized on this behalf after examining all the documents and the inspection report of the Inspector of Legal Metrology is of an opinion that licence can be granted to the applicant considering the recommendation made by the Assistant Controller of Legal Metrology; the licencing authority shall communicate to the applicant for online payment of the Licence fees. After depositing the Licence fee the Licence will be granted and the same may be download from the Departmental Website. The process shall be completed within 7(seven) working days.

## *I.* How to Apply?
